#### KRSCNA Treasurer's Report for January 15, 2023

#### Hello Family,

On January 1, 2023 I went to our bank account to print the bank statements and see how the account looked and I noticed an EFT withdraw for \$ 18,868.58 had happened. My heart skipped a beat and my stomach flipped over. I'm like holy shit someone has hacked our account. I tried to call the 800 number for our bank but it was a holiday. I called Tony and told him what was going on and he told me to call the bank on Tuesday and tell them what had happened. Long story short I filed a Fraud incident report and answered a bunch of questions asked by the bank and I froze our account until I heard back from them.

On Saturday 1-7-23 I called the banks fraud department number they gave me and was told our money had been put back into our account. Right now our account is still froze until we decide what we Wanted to do. Re-open our account or start a new account with a new account number. Our debit card wasn't compromised and they told me someone used the routing and account number. Tony said it most likely was a bank teller error and it happens more than people realize. Anyway all our money is there and I'm grateful we got it back.

We now have the bank statements going to a different address than mine but I downloaded the November & December bank statements along with a Bank balance from 1-12-2023 for our meeting today. I also have the quicken

register report. We have a current balance of **\$ 27,695.48** in our account. I wrote two checks in the past two months. One to the World Service Office of NA for \$ 5,000, the other check went to WD Insurance Co. for liability insurance for \$1,123.02. I did deposit five checks and those checks are listed on the check register report and below. If anyone has any expense's you can mail the receipts so I have them to file.
