

RCM Report from July KRSCNA meeting

Hello Family,

The Regional meeting was held on July 16.

All but two areas were in attendance.

Regional Treasurer's Report:

- We currently have a balance of \$33,310.80 in our account.
- KRCNA returned the seed money (\$6,000) + profit (\$3,569.17) and 40% of that profit goes to World.
- LASCNA area donation of \$1,000
- OVANA area donation of \$500
- SCKASCNA area donation of \$79.99

Old Business:

- Region is looking into getting 501 C3 status. More info to come as Tony J, Mark, and Rachel look into it.
- Motion 3-1-23 Passed
- Motion 3-2-23 Passed
- Rodney B was voted in as Regional Delegate Alternate
- We got the NA tablecloths (usually used for PR functions) from Gadzooks, but they are still working on the backboards. Region has two tablecloths that will be shared between areas as needed. The backboards will also be shared between areas as needed.

New Business and/or Motions for Areas to Vote on:

- For Areas to vote on: 502 Area made a motion to send \$10,000 to World as a one-time donation. (See Treasurer's report.) Below is some context:
 - We currently have over \$30,000 in our account. \$6,000 of that is for KRCNA seed money and some portion is for operating expenses (storage space, etc.) and funds requests from Areas, but that still leaves us with well over \$20,000 in the bank account.
 - The Regional Treasurer agrees we will still have plenty of funds after the \$10,000 donation to World.
 - An ad hoc group is looking into making a plan for a routine periodic donation to World depending on the Regional balance.
- ATRA made a motion to pay the whole year of storage rental. Floor vote was taken and motion passed.
- <u>For Areas to vote on</u>: Louisville Area made a motion requesting \$500 seed money for H&I/PR Learning Day on October 7. This will be voted on at Region in September. (Sorry for any confusion from me on this. I had misunderstood the May minutes and thought that they had floor voted on this but I don't think they did!)

The next Regional meeting with be September 17, 2023 at Land Between the Lakes.

OVANA Public Relations Subcommittee Would like to request a total of \$735 for using in local public relations. The breakdown of the ask would be that we have:

- \$200 for business cards and flyers that contain the area helpline number. This is of paramount importance due to the area getting a new phone number
- \$70 for 3 4-tier acrylic info stands with cardholders that will be left and repeatedly filled with NA IPs in facilities such as treatment facilities, libraries, and jails
- \$65 for IPs that will fill all acrylic info stands for the remainder of the year.
- \$150 for NA Basic texts to be placed in public libraries, local jails, and halfway houses
- \$250 for promotional items that will be displayed on the Narcotics Anonymous booth at various recovery events to attract new members. OVANA has attended one event like this already this year with a plan to attend one more this October. We plan on these promotional items lasting through all events through 2024 due to minimum purchase requirements on custom promotional items. These items will contain our helpline number and may also be placed near info stands left in treatment facilities. These items could include but are not limited to
 - Magnets
 - Pens
 - Stress balls
 - Frisbees
 - Lanyards
 - Fidget Spinners
