

Proposal 1029231, From Jason H. Treasurer, ovana debit card PASSED

Proposal 1029232, From Troy B. P&P Chair, Combining 3 areas for mtg. schedule PASSED

2 Regional Motions:

- (Motion 9-3-23) FAILED ATRA asking for \$2,000 for a Billboard in their area intent carry message. The Billboard would be up for 12 weeks. The Regional Secretary did not send out any motion form for this motion, so it is unclear if ATRA submitted any additional written information.
- (Motion 9-4-23) **PASSED** OVANA requesting \$735 for the Public Relations Subcommittee. The breakdown of the ask would be that we have:
 - \$200 for business cards and flyers that contain the area helpline number. This is of paramount importance due to the area getting a new phone number.
 - \$70 for 3 4-tier acrylic info stands with cardholders that will be left and repeatedly filled with NA Ips in facilities such as treatment facilities, libraries, and jails.
 - \$65 for lps that will fill all acrylic info stands for the remainder of the year.
 - \circ \$150 for NA Basic Texts to be placed in public libraries, local jails, and halfway houses.
 - \$250 for promotional items that will be displayed on the Narcotics Anonymous booth at various recovery events to attract new members. OVANA has attended one event like this already this year with a plan to attend one more this October. We plan on these promotional items lasting through all events through 2024 due to minimum purchase requirements on custom promotional items. These items will contain our helpline number and may also be placed near info stands left in treatment facilities. These items could include but are not limited to: magnets, pens, stress balls, frisbees, lanyards, and fidget spinners.

New Business:

Nomination from Hope for Us for Benie B. for Vice Chairperson was held until next meeting, with the rest of the nominations. Please bring your group's previous votes for or against Benie B.

Three Nominations were received from Women's Power Within. All three are currently holding the position. All three read their resumes at the meeting.
