We are still in need of a Region Secretary. Below is a short description of the position. The full description can be found in the Region P&P in the KRSCNA website. Please encourage any qualified individuals to apply. This is a crucial position for the region and a fairly low time commitment (2 hours every other month, plus typing up and emailing out the minutes). Region meets via ZOOM so no travel is required.

SECRETARY:

We collected \$150 in donations and given to treasurer for H& I use. Others planned to donate using Zelle.

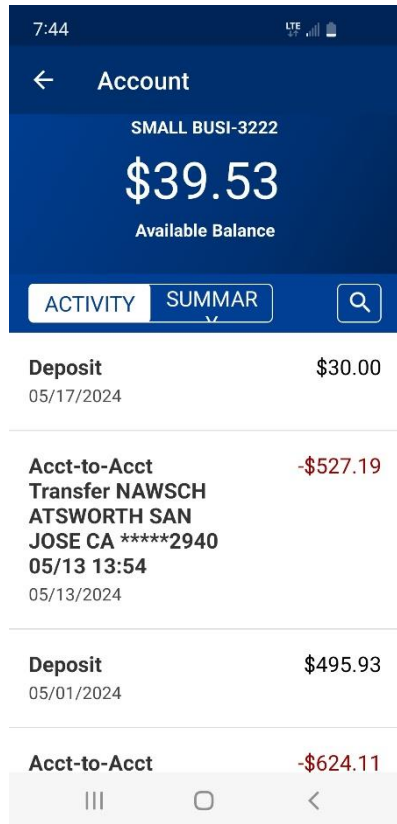
We meet again June 30 at 1pm at fctc.

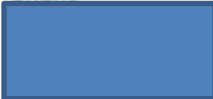
