#### JULY 2024 Regional meeting report to OVANA

Hello Family,

We have a current balance of \$26,907.20 in the KRSCNA bank account. This is after depositing the KRCNA profits (\$10,024.86) and then sending 40% of the KRCNA profits to World.

KCRNA 37: Karen D (502 area) has had to resign her position as KRCNA chair due to health reasons. There was discussion about possibly moving KRCNA 37 to Owensboro if no one from 502 area can step into the position. Region (Mark S) will contact 502 to see if someone can step up.

Southern Zonal Forum has been discussing gender neutral language in our literature. They have asked World to start looking into the feasibility/cost of that. Our Region's Southern Zonal Representative did not submit a written report to Region so we don't have details on how that played out at the Southern Zonal Forum. Mikey P will contact the SZF office to get the minutes from the SZF to see which motions passed, which ones referred to World Board, etc.
