## RCM:

November 2025 RCM report.

Hello family.

I attended last Sunday's regional meeting at the Floyd County Token club.

The minutes are not ready yet. Therefore, I will provide you with what I wrote myself.

Regional treasurer report: Current balance is \$30,758.05 3 deposits were made within the last 2 months. These include: 2 area donations \$102.00 from SCKANA and \$1000.00 from Louisville.

The other deposit of \$9,357.09 was from the KRCNA convention seed money and profit. Mark S. broke down everything related to the KRCNA profits:

Total profits: \$9357.09- \$6000- seed money= \$3,357.09 – 60% profit to region =\$2014.26 and 40% \$1342.83 went to WSO of NA.

502 Area is no longer in the KRCNA Regional rotation due to not being present for the regional meetings. A letter of concern was sent, and no response was received. This means that we need to vote on the rotation, again. Motion from project chair motion number 6-1-25 proposed regional events rotation starting January 2027.

Louisville is up to host KRCNA 40 convention in 2027.

Pennyrile to host in 2028

OVANA in 2029

Owensboro in 2030

Across the River in 2031

If any area opts out of hosting the convention, then we will ask the next area in rotation to host. I have asked someone to clarify if the area will need to host back-to-back conventions.

The project chair sent a flyer of the proposed rotation to the regional secretary. I will have more information next month.
