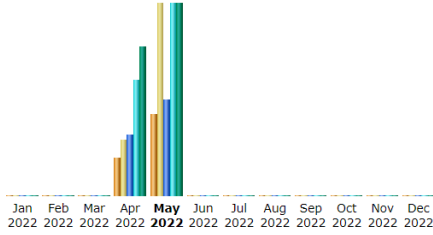
Good afternoon fellow Addicts,
